Terms & Conditions:

Part one

Under these Conditions, the term 'Exhibitor' means the signatory of the application which includes all employees and/or agents of such; and the term 'Exhibition" means the Gulf International Flowers and Gardens – WARD 2022 and "MOTION" means MOTION INTERNATIONAL EXHIBITIONS & EVENTS'

The Exhibitor location is only confirmed once the complete deposit of the total amount due has been received upon signing of this Contract.

Stand rentals may be paid in US Dollars or UAE Dirhams. All bank charges to be borne by the Exhibitor.

In case of joint venture howsoever described, the Exhibitor is deemed to have obtained the consent of all the co-exhibitor(s) to all the conditions of this Contract. Without prior written consent from MOTION', the Exhibitor is not permitted to share the Space with any undeclared co-exhibitor (s) who has not paid the full participation fee. Should the Exhibitor be permitted to do so, the Exhibitor remains responsible for the Space in its entirety, In the event of a breach of this Contract, both the Exhibitor and the co-exhibitor(s) shall be liable.

- 1. If the Exhibitor does not pay the balance of the contract price at the prescribed time, MOTION*reserves the right after written notice to the Exhibitor to cancel the booking. In the event, that the Exhibitor cancels the booking after the application is granted, the deposit will be forfeited. Additionally, if cancellation occurs for either reason after the prescribed date for payment of the balance of the contract price, a sum in liquidated damages equivalent thereof will be payable by the Exhibitor to MOTION' in any event. If MOTION' does not receive the payments into its designated bank account by the due date. MOTION' reserves the right to refuse entry to the Exhibitors related representatives, employees and withhold Exhibitor Participation.
- Applications submitted by the Exhibitor must contain all details of the proposed exhibit and the name of any representation they are entitled to which they want to exhibit with all products and services being mentioned.
- 3. MOTION' has/have full power to decide how the exhibition layout is designed and applied with full right on its own sole opinion to change any Exhibitor location as Motion deems necessary with the need for any form of approval by the Exhibitor. The Exhibitor shall accept the new allotment of space without any form of objection.
- 4. Motion is fully responsible and on its own to the Design, Space Allocation of Exhibitors, without any restrictions but, if possible, still taking account Exhibitors wishes if they are deemed possible by Motion, also, the layout of the stand/space itself, as well as the application date submission/registered if necessary. Should an application request a space, but due space was already registered prior by a different entity then Motion will try its best to provide a similar space of size or location if it is possible without overburdening Motion, Payment and Date Submission of application will also play role into determine stand final location. If Motion determines an Exhibitor location is final, then said Exhibitor is fully aware of it and will not overburden Motion with unreasonable requests. Part 2

- 5. Upon the acceptance of the Exhibition Space Contract, a contract shall arise between MOTION and the Exhibitor with regards to space requests/allotted, and a relationship of the licensor and the licensee shall be created between MOTION and the Exhibitor. Not a single item in this Contract shall be constructed as granting the Exhibitor any right, permission, or license to use or exploit the Intellectual Property Rights of MOTION and any of its representatives unless specially granted in written form from MOTION to the Exhibitor. In case of non-payment of any sum due or any breach or non-observance of any of these conditions by the Exhibitor, MOTION reserves the full right to revoke this license and to reenter upon the allotted space and may remove and exclude the Exhibitor without prejudice to recovering all monies payable hereunder, all other claims against the Exhibitor and the right to recover damages sustained by MOTION'].
- 6. The Exhibitor shall occupy the allotted space by 8:00 am on the opening day of the Exhibition. 48 Hours for preparation (November 19, 2022) and 24 hours for disposal (November 25, 2022). In the event of a default due to any cause whatsoever, the Exhibitor shalt pay to MOTION' a further sum in liquidated damages equal to the total charge for the space and MOTION has the right to deal with the space in any way it thinks best and has the right to manage the space accordingly at its own discretion.
- 7. Exhibitor is fully responsible for his allocated space even if display material does not arrive for whatever reason.
- The Exhibitor is not allowed in any form to sublet, assign, grant any licenses in respect to the space allotted, nor show any other entities advertisements, material unless mentioned as co-exhibitor in the form submitted.
- 9. Should the Exhibitor withdraw, without prejudice to the rights and remedies of MOTION in respect of any breach of the contract on the part of the Exhibitor, MOTION at its discretion, may allow the Exhibitor to withdraw from the Exhibition subject to the following conditions:
- The Exhibitor must give provide a written notice if the entity decides to withdraw from the Exhibition, If MOTION allows the withdrawal, it will be in written form only, and MOTION reserves the right to resell the stand to another entity.
- Any such notification by MOTION to the Exhibitor will constitute cancellation of the contract subject to the payment by the Exhibitor to MOTION of consideration for release from the contract.
- The amount for such payment will be specified in MOTION's notification to the Exhibitor and will be that amount of the space rental payable under the contract here specified.
- If notice of withdrawal is received before October 01, 2022, the amount of space rent payable is fifty percent (50%).
- If notice of withdrawal is received on or after October 01, 2022, the amount of space rent payable is one hundred percent (100%).
- Upon payment of such amount to MOTION by the Exhibitor (credit being given by MOTION' for all the rentals already paid by the Exhibitor) the contract shall be canceled and neither party shall pay any further claim against the other.

Part Three

- 11. The Exhibitor is not permitted in any shape or form without written consent from MOTION to bring into the Exhibition any form of dangerous material such as Explosives, Radiated, Chemical, Noxious Fumes or any other hazardous material. If the Exhibitor fails to notify MOTION of such material, then Motion reserves the right to legally remove the Exhibitor and all their representatives from the Exhibition with also, informing official entities about such breach. - 12. The Exhibitor shall hold MOTION safe and harmless from all loss or damage suffered by or arising out of any of default of any servant, agent, employee or subcontractor of the Exhibitor. MOTION' cannot accept any complaint or claim against them unless it is submitted in writing to the address given below within two weeks of the closing date of the Exhibition. All claims and disputes shall be settled in accordance with Clause 28 vi of this Contract.

13. Insurance.

The Exhibitor shall, throughout *the* duration of the Event, at its own expense, obtain and maintain insurance based on the following:

- The Exhibitor is required to purchase insurance in the form of Public Liability and Property Insurance for the entire event duration by approved Insurance providers.
- The complete terms and conditions of the insurance are available in the Exhibitor's Manual which will be handed out.
- Exhibitors must provide MOTION with a copy of their insurance policy. The Exhibitor's insurance policy should commence at least three (3) three weeks prior to the Event if MOTION considers this necessary.
- Motion will under no circumstances be liable for any insurance claims including the loss of business.
- The provisions of this Clause 17 shall not prejudice any liability of the Exhibitor to MOTION' under any other provisions of this Contract.
- 14. MOTION reserves the right at any time to change, alter, add and amend any conditions it sees, and such changes are final.
- 15. An Exhibitor Manual will be provided contained information and instructions to the Exhibitor.
- 16. The Exhibitor is fully aware that any display/advertising material shall be appropriate and follow the common understanding of the Exhibition. It shall be displayed and designed in a proper form and will follow local laws as mentioned in the UAE's laws and regulations. If Motion deems it necessary, it will request from the exhibitor to change/amend it as it sees fit. Once informed the Exhibitor will change immediately.

- 21. Change, Postponement or Cancellation of Exhibition for reason(s) other than Force Majeure.
- 21.1 The below applies in the occurrences of the following scenarios:
- Change, Postponement of Exhibition Dates and/or Venue, (whichever applicable) for reason(s) other than Force Majeure.
